Proposed Budget 2024-25

Dear District Residents,

I hope this letter finds you and yours enjoying our spring season!

Our budget highlights for our current (2023-2024) school year included numerous additional student-centered supports that have resulted in positive returns on our investments.

One example is our continued three-pronged approach to increasing student reading achievement. Our commitment to smaller class sizes by hiring additional teachers, implementing new instructional resources, assessments, and providing additional instructional professional development has resulted in our students' reading proficiency rates soaring to unprecedented levels of 80-90 percent.

Other examples of positive returns on our investments for the current 2023-2024 school year budget highlights include:

- Implemented new math instructional resources to increase student achievement.
- Implemented District provided school supplies to ensure increased student equity and access as well as enhance efficient use of valuable class time.
- Expanded District full-day Pre-K program to 5 classrooms, expanded the number of seats in our Pre-K community partners' programs and implemented new instructional resources and professional development. This has yielded an increased number of Pre-K students achieving Kindergarten readiness.
- Increased the number of Brockport High School courses that offer both high school and college credits, empowering students to embark on their post-graduation endeavors with confidence.
- Upgraded BHS Auditorium sound system.



For the upcoming 2024-2025 school year, our budget highlights include:

- Continue District provided school supplies to ensure increased student equity and access as well as enhance efficient use of valuable class time.
- New Early College High School graduation pathway, enabling our interested students to earn both high school graduation credits and college credits toward a college Cyber Security degree.
- New Freshman Foundations course for all freshman to improve the successful transition to our high school and better support students for postgraduate success.
- Piloting a Personal Money Management course (financial literacy) to ensure students are better prepared for postgraduate personal financial management success.
- Increase AVID opportunities at our middle and high schools to ensure the success of all students.

You will see the following items on the 2024-25 Proposed Budget ballot for the May 21, 2024, vote:

Proposition 1: 2024-25 Proposed Budget

The 2024-25 proposed \$96,916,604 budget is balanced with a zero-tax levy increase and is composed of State Aid, District Income, and Local Share. This also includes bus purchases/trade-ins utilizing \$725,000 from the 2021 Bus Purchase Capital Reserve Fund.

Board of Education Member Election

Three member positions on the Board of Education are open for election. Two Board of Education members will be elected to serve five-year terms beginning July 1, 2024 and one member will be elected for a two-year term beginning May 21, 2024. The terms of members, Terry Ann Carbone and Kathleen Robertson, will expire on June 30, 2024. The third board member position is the remaining term of former Board member Daniel Legault, which is currently held by Board Member David Stroup. Please see page VI for additional information.

Three Part Budget Summary of Expenditures

New York State law requires that school districts present the proposed budget in three parts: Administrative, Educational Program and Capital.


Administrative Component - includes expenses for the Board of Education, central administration, instructional supervision, curriculum development, legal services, central data processing, printing, mailing, storage, and employee benefits attributable to salaries included in these functions. The administrative component experienced an increase of 4.69%, with most of this rise being attributed to the implementation of enhanced IT security hardware and software.

Educational Program Component – includes expenditures for instructional programs, school library/audiovisual, attendance, counseling, health services, interscholastic athletics, student transportation, transfers to special aid fund, and employee benefits attributable to salaries included in these functions. The educational component saw a 4.39% increase. The district remains committed to reviewing enrollment and staffing to identify efficiencies. With the recent growth in enrollment and the increasing social-emotional needs of students, the district has found it necessary to hire additional teachers and mental health staff.

Capital Component – includes expenses for operations and maintenance, grounds, security, utilities, principal and interest payments for debt service, transfers to capital fund, property tax refunds, and employee benefits attributable to salaries included in these functions. The capital component experienced an increase of 7.41%. Of this, \$260,000 is allocated to the Building Condition Survey, which the district is required by law to conduct every five years. Additionally, \$665,000 of the increment is associated with the acquisition of buses, including one large electric bus.

^{**}Each year New York State allows school districts to expend \$100,000 in capital project work and receive building aid for this work. As part of the proposed 2024-25 budget the district plans to do roofing and masonry repair at the High School.

Answering your tax-related questions

What is Brockport's allowable tax levy limit?

Brockport's allowable tax levy limit is 2.78% for a simple majority vote. The proposed tax levy increase is 0%. To see Brockport's tax cap calculation, visit www.bcs1.org/2024-25budget.

What is an "allowable tax levy limit?

For school districts, the "tax levy limit" is the highest allowable tax levy (before exemptions) that a school district can propose as part of its annual budget for which only the approval of a simple majority of voters (more than 50 percent) is required. Any proposed tax levy amount above this limit will require budget approval by a supermajority (60% or more) of voters.

Essentially, the "tax levy limit" sets a threshold requiring districts to obtain a higher level of community support for a proposed tax levy above a certain amount.


However, the new legislation does not place a limit on any taxes a school district would levy to pay for expenditures related to specific "exempt" items, including some court orders, some pension costs and local capital expenditures. These items are then added to the "tax levy limit" to arrive at the "allowable" tax levy limit.

The major sources of projected revenue for the 2024-25 school year are shown in the graph. State aid accounts for 52.13% of revenues. The local share, which represents local property taxes and STAR, accounts for 36.92% of revenues. District income, which represents all other sources of revenue, accounts for 10.95% of revenues.

Statement of assumptions made in projecting a contingency budget, pursuant to section 2023 of the Education Law, for the 2024-25 school year, should the proposed budget be defeated.

If the school district budget is defeated twice, state law requires a board of education to adopt a contingency budget. A contingency budget includes only those expenditures allowed under New York State regulations. Expenditures such as certain new and replacement equipment, salary increases for certain employees and student supplies would be eliminated. There would also be mandated charges for use of school facilities by outside organizations.

Final tax rates are established in August, when the tax rolls are prepared. These figures are only projections and are subject to adjustments. Projections are based upon the latest assessed values provided by the individual town assessors, and equalization rates established by the New York State Office of Real Property Tax Services.
